Martin Gracey Award



John Johnson, founder and longtime director of Hampton Ecumenical Lodging and Provisions (H.E.L.P.), was honored at our May 27th meeting with our Martin Gracey Award for Extraordinary Service.

The award is named for Martin Gracey, a member of

the Rotary Club of the Virginia Peninsula who was noted for his humor, abilities as a raconteur, high ethical standards and his generosity in giving to the club and the community. The award is bestowed periodically upon a person or organization that has done something especially significant—and of lasting value—for business or the community.

H.E.L.P. was founded in 1982 in the midst of a deep recession in which homelessness, hunger and financial stress abounded. In his acceptance remarks John remembered back to the remarkable story of the organization's founding. About sixty people, he recounted, most of whom didn't know each other came together to discuss the community's response to the crisis. Two hours later, they knew exactly what they wanted to do and what had to be done. Within days, doors opened and phones rang as people, businesses, religious organizations and other groups began calling to volunteer services, resources and money. With John's leadership, H.E.L.P. opened Hampton's first Family Shelter and first Free Clinic.

John is currently Executive Director of the Hampton Citizens' Unity Commission that works to make the city of Hampton "a healthy diverse community." Under his leadership, the commission has won numerous awards. John's personal achievements have been recognized by many local, state, national and international awards including a papal award (Pope John Paul II's Benerementi Award) in 2003.

John and his wife, Susan, have resided in Hampton Roads since 1978. They are parishioners of Immaculate Conception Catholic Church.

Past recipients of the Gracey Award include Paul Trible, President of Christopher Newport University; Robert (Bobby) Freeman, founder of Newport News Public Art Foundation and Port Warwick Development; and Harry Wasson, founding member and benefactor of the Virginia Living Museum.


